ABOUT OUR RATES

Based on a MD Commission Order issued April 9, 2021, Washington Gas Light Company (“Washington Gas” or “Company”) customers will see new rates in their May bills. The Company had filed an application to increase rates on August 28, 2020.

COMPARISONS OF CURRENT AND APPROVED CHARGES

Unless otherwise noted, the comparisons of current and approved charges below apply to “firm customers,” which are those who receive continuous natural gas service, without interruption, except in the event of an emergency. The changes noted below do not affect the Purchased Gas Charge, a direct pass-through cost paid by Washington Gas sales service customers (those who purchase natural gas directly from Washington Gas).
